- Classes may be combined, split or cancelled.
- Boots, Long Sleeves & Long Pants Required
- Refunds only with veterinarian's or doctor's slip.
- Helmets suggested & welcome for all riders.
- Any Equine or rider deemed out of control will be excused.
- Youths entered in 13 & Under, & Leadline classes Must wear ASTM/SEI approved Helmets
- No Cross Entry Between Leadline & other divisions
- No Cross Entry Between 13 & Under and any canter classes.
- Youths entering 13 & under classes cannot also enter 10 & under classes regardless of their age
- Novice: Must not have won more than two blue ribbons at any horse show. This class will include the canter.
- NO DOGS ALLOWED ON THE PROPERTY!
- NO SMOKING ON THE PROPERTY!
- Points tabulated as follows:  
1st=10pts, 2nd=8pts, 3rd=6pts, 4th= 4pts, 5th=2pts, 6th=1pt

You are advised that there are inherent risks, including the risks of serious injury or death, while engaging in equine activities. By engaging in equine activities, and in accordance with the terms of this Agreement, you hereby assume all risks of injury or death.
